Note: 1. Bidder are requested to make a site visit for assessment of the requirement before submission of the bids.

- 2. The required staffs, technicians, event manager, programme campaigner, receptionist, man power for arrangements, security, cleaning, loading, unloading, labour all etc., before the start of the event and upto the end of the event shall be arranged by the Agency. The location should be cleaned properly and disposal of the entire erected materials in a safe manner. (The above provisions are inclusive in the rates quoted for the above items including any incidental expenditure)
- 4. No Advance payment shall be paid to the successful bidder.
- 5. In case of postponement of the event no additional charges will be paid.
- 6. In case of cancellation of the event, the payment shall be made to the bidder on pro-rata basis as per actual work done which shall be decided by the Committee of NHAI.
- 7. Particulars under scope of work are tentative only. Payment will be made as per actual supply and measurement of items of works.
- 8. The bidder should have experienced in similar nature of work. Documentary evidence of execution of similar nature of work in connection with inauguration, foundation stone laying, any Govt programme shall have to be submitted alongwith the Quotation.
- 9. The rate should be quoted both in figures & words. In case of any discrepancies, the rate quoted in words will be prevailed (No any overwriting to be entertained).
