The Scope of Work includes Road maintenance, Road Property management and other maintenance, safety Improvement (Engineering works), Incident management, miscellaneous works and rectification of bridge for a period of 6 months.

The bids would be opened on 30<sup>th</sup> **May 2023 at 15.00 hrs** online at NHAI RO-Kerala, AMBLY ARCADE, TC 86/1036-1, S.N.N.R.A - 9, PETTAH - P.O., Thiruvananthapuram -695024 representatives of the bidders (maximum of two) who choose to attend, may attend the online opening of the bids at NHAI RO-Kerala on the date and time as mentioned above. However, such representatives shall be allowed to attend the opening of the bids only if they produce letter of authority on the letter head of the bidder, at the time of opening of bids as mentioned above.
