The Scope of work includes **Construction of New Service Road from Amravati Enclave to Burj Kotia Lights from km. 52.180 to km. 53.100 RHS on Zirakpur-Parwanoo section of (Old NH-22) (New NH-05) in the State of Haryana** on item rate (percentage) basis and further detailed information regarding the scope of work may be seen in the Bid Document.

It is mandatory for all the bidders to have class-III Digital Signature Certificate (With Both DSC components, i.e., Signing & Encryption) in the name of authorized signatory (who will sign the Bid) from any of the licensed Certifying Agency (Bidders can see the list of licensed CA's from the link [www.cca.gov.in](http://www.cca.gov.in) to participate in e-tendering of NHAI.

To participate in the e-bid submission, it is mandatory for the Applicants to get themselves registered with the NHAI e-Tendering Portal (<https://etenders.gov.in>) to have a user ID & Password. The detailed tender document can be viewed/downloaded/purchased from the website <http://etenders.gov.in> from **16.03.2024 to 08.04.2024 (upto 11:00 AM)**.

The complete Bid Document can be downloaded from the NHAI e-tendering portal free of cost. To participate for bidding, bidders have to pay a non-refundable document fee to "National Highways Authority of India" in the form of online mode only as mentioned above. The amendments/clarifications to the bid document if any would be hosted on the above website.

The bid should be submitted online in the prescribed format given in the website. No other mode of submission is acceptable. However, Bid Security, POA for signing the Bid, Integrity Pact, and experience certificates, and other documents specified in clause 12.2 of RFP shall be submitted physically in original by the Lowest Bidder before issuance of Letter of Acceptance (LOA) by the Authority. Further, while submitting Bid Security via Account Payee demand draft, it is to be ensured by the bidder that Account Payee demand draft are submitted physically latest **within 5 working days of the Bid Due Date (upto 11:00 hours)**.

The authorized signatory holding Power of Attorney or the person executing/delegating such POA shall only be the Digital Signatory. In other cases, the bid shall be **considered non-responsive**.

The last date submission of Bid through online is **08.04.2024 upto 11:00 Hrs. (IST) as mentioned on the e-portal only ("Bid Due Date")**. **The bids (technical) would be opened on 09.04.2024 at 11:30 Hrs.** online at NHAI, RO Chandigarh, Bays no. 35-38, Sector-4 Panchkula, (Haryana) – 134112, representatives of the bidder (maximum of two) who choose to attend, may attend the online opening of the bids at NHAI, RO Chandigarh on the date and time as mentioned above. However, such representatives shall be allowed to attend the opening of the bids only if they produce letter of authority on the letter head of the bidder, at the time of opening of bids as mentioned above. NHAI reserves the right to accept /reject any or all the bids without assigning any reasons thereof.
