Annexure-A TERMS & CONDITIONS FOR ENGAGEMENT OF RETIRED STATE GOVT REVENUE OFFICER ON PURELY SHORT TERM CONTRACT BASIS

1. Scope of Service:

The major scope of the work of the Retd. Revenue Officer are as follows.

To provide Assistance to the Regional Officer regarding the following aspect.

- (a) To liaising with the state Government officials for land acquisition matter.
- (b) Monitor the progress of LA targets across projects.
- (c) Collate monthly reports in a pre-determined format.
- (d) Scrutiny and processing of 3G award estimates/ Arbitral award and as per order passed by the District Court/ High Court/ estimates received from the respective CALAs.
- (e) Coordinate with PDs and CALAs to expedite disbursement of compensation in time bound manner.
- (f) Coordinate with PDs and CALAs to expedite mutation of acquired land in favour of central Govt in record of right.
- (g) Submission of accurate data on land acquisition to Competent Authority, and officials of other concerned departments, for land acquisition.
- (h) Information regarding status of land.
- (i) already acquired/to be acquired and LA compensation deposited with CALAs.
- (i) Monitoring/Obtaining utilization certificate of fund deposited with CALAs.
- (k) Monitoring/Providing information regarding Court Case relating to Land Acquisition.
- (l) Any other activity including field work as demanded by Regional Officer time to time for completion of LA activity.

2. Duration of Engagement:

The engagement shall be for a period of six months and from the date of acceptance of the appointment letter. The contract can be terminated at any time without notice and without assigning any reason. In the case of termination, no compensation will be payable, Extension/Termination of service be solely dependent upon discretion of NHAI. Service rendered on contract with NHAI shall in no way give any right to claim regularization /absorption in the Organization.

- (A) Expected profile of Retd Govt. Revenue Office Should be retired Revenue Officer of the relevant State Government.
- (B) Minimum Experience: Having sufficient experience preferably minimum 10 (Ten) years in the field of land Acquisition Land and Land Reforms/ Survey works.
- (C) Monthly Remuneration Upto Rs. 35000/- per month or last pay drawn reduced by pension in terms of para 3 (d) (iii) of circular No- NHAI/12/LA/ Policy /2006/10 dated-03.10.2006 & modified circular policy no- 7.1.74/2021 dated- 01.11.2021. The amount of remuneration for the persons engaged shall be increased by 5% per annum during their period of engagement.
