DETAILS OF ELIGIBILITY CONDITIONS

1. Position	Joint Advisor (Technical) - CCIE
2. Number of Posts	02 (Two)
3. Method of Recruitment	Contract basis through open advertisement
4. Period of Contract	Initial tenure of engagement will be two years in the first instance, which may be further extended by one more year, based on the requirements of the NHAI and the satisfactory performance. NHAI reserves the right to terminate the contract at any time, without assigning any reason.
5. Remuneration (per month)	In respect of retired Employees of Central/ State Governments, Autonomous Bodies/ PSUs, etc., the Monthly Remuneration (Last Drawn Basic Pay – Pension + Transport Allowance) + *Domain Specialization Charges, Telephone/ Internet Charges and Hospitality Charges, will not exceed the Maximum Ceiling of Rs. 1,75,000/- as applicable in terms of EP/ YP Guidelines dated 21.06.2017 (amended from time to time). *Maximum Limit of Domain Specialization Charges, Telephone Charges and Hospitality Charges per month are Rs. 80,000/- , Rs. 2500/- and Rs. 2,500/- respectively

6. Educational qualification and experience required	I. Graduation in Civil Engineering from a recognized University / Institute. II. Should have retired from Central / State Government / PSU / Institute at the level equivalent to an Executive Engineer or above but below the level of Chief Engineer with experience in contract management / arbitration / conciliation matters of infrastructure projects.
7. Desirable Qualification	Degree in Law from a recognized University / Institute.
8. Age limit	Not exceeding 65 years as on the prescribed date of receipt of online applications.
9. Vacancy Places	NHAI-HQ
