Addendum

With reference to our earlier advertisement published in Navbharat Times on 06.08.2015 for the post of Manager(Tech.) on direct recruitment basis , the following vacancies are reserved for Persons With Disabilities as under and hence, applications are invited from the Persons With Disability for the same subject to meeting the other eligibility criteria and all extant terms and conditions as mentioned below:

2. The following terms and conditions will be applicable in case of applications are received from the Persons with Disability:

- I. The definition of disabilities for reservation in the matter of vacancies for physically challenged candidates is as per "The Persons with Disabilities (Equal Opportunities, Protection of Rights and Full Participation) Act, 1995.
- II. Only such persons would be eligible for applying against the advertisement who suffer from not less than 40% of relevant disability
- III. The PWD candidates are required to furnish duly stamped Medical Certificate in relation to their disability from Government Hospital or Medical Board attached to Special Employment Exchange for the handicapped.
- IV. The Competent Authority to issue Disability Certificate shall be a Medical Board duly constituted by the Central or a State Government. The Central /State Government may constitute Medical Board(s) consisting of atleast three members out of which at least one shall be a specialist in the particular field for assessing locomotor/Cerebral/visual/hearing disability, as the case may be.
- V. Applications not submitted **strictly** in the prescribed format or through proper channel or without NOC or incomplete in any respect or without Disability Certificate in prescribed format issued by Competent

Authority shall be liable for summary rejection. The candidates are advised to fill the application format carefully in accordance with the eligibility criteria mentioned above. It may be noted that any subsequent clarification regarding job profile/ experience, etc. at a later date will not be entertained under any circumstances.

- VI. Relaxation of 10 years in upper age limit for PWD candidates is admissible, i.e. total relaxation in upper age limit will be 10 years for General, 13 years for Other Backward Class and 15 years for Scheduled Caste / Scheduled Tribe candidates.
- VII. All other terms and conditions regarding fulfilling the eligibility criteria pertaining to educational qualifications and essential experience would remain the same as applicable in the case of earlier advertisement for the post of Manager(Tech.) on direct recruitment basis, which may also be seen on NHAI's website.
- Viii **The last date of receipt of applications is therefore extended upto 12.10.2015.** It may please be noted that the applications received through e-mail or fax shall be summarily rejected. This notice is also available on NHAI website: **<http://www.nhai.org>**. **The envelope containing the application should be super-scribed with the name of the post applied for.**
